A BILL

To amend section 114 of title 17, United States Code, to provide for agreements for the reproduction and performance of sound recordings by webcasters.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Webcaster Settlement
5 Act of 2008”.

1 **SEC. 2. AGREEMENTS ON BEHALF OF WEBCASTERS.**

2 Section 114(f)(5) of title 17, United States Code, is
3 amended—

4 (1) in subparagraph (A)—

5 (A) by striking “small commercial” each
6 place it appears and inserting “commercial”;

7 (B) by striking “during the period begin-
8 ning on October 28, 1998, and ending on De-
9 cember 31, 2004” and inserting “for a period
10 of not more than 11 years beginning on Janu-
11 ary 1, 2005”;

12 (C) by striking “a copyright arbitration
13 royalty panel or decision by the Librarian of
14 Congress” and inserting “the Copyright Roy-
15 alty Judges”; and

16 (D) in the second sentence, by striking
17 “webcasters shall include” and inserting
18 “webcasters may include”;

19 (2) in subparagraph (B), by striking “small
20 commercial” and inserting “commercial”;

21 (3) in subparagraph (C)—

22 (A) by striking “Librarian of Congress”
23 and inserting “Copyright Royalty Judges”;

24 (B) by striking “small webcasters” and in-
25 serting “webcasters”; and

1 (C) by adding at the end the following:

2 “This subparagraph shall not apply to the ex-
3 tent that the receiving agent and a webcaster
4 that is party to an agreement entered into pur-
5 suant to subparagraph (A) expressly authorize
6 the submission of the agreement in a pro-
7 ceeding under this subsection.”;

8 (4) in subparagraph (D)—

9 (A) by striking “the Small Webcasters Set-
10 tlement Act of 2002” and inserting “the
11 Webcaster Settlement Act of 2008” ; and

12 (B) by striking “Librarian of Congress of
13 July 8, 2002” and inserting “Copyright Royalty
14 Judges of May 1, 2007”; and

15 (5) in subparagraph (F), by striking “2002”
16 and all that follows through “2003” and inserting
17 “2008”.
